If ALT.tf's EULA's are updated at any point, THE LICENSEE will not be bound by its changes, rather, the license that THE LICENSEE is provided at the time of purchase is locked, and will remain the license THE LICENSEE must abide by in perpetuity.

This document suppresses any other agreement oral or written between ALT.tf and THE LICENSEE. IP Ownership

The typeface and / or the software and / or font software represented by this contractual agreement remains the intellectual property of ALT.tf or its relevant Creator(s).

A User, Not An Owner

After the font license purchase has been made, THE LICENSEE becomes a licensed USER, NOT an owner of the software.

Licensed Users & Locations

This EULA is a single (one) USER license.

Enterprise Licensing

If THE LICENSEE is a business and wishes to license the font software to multiple locations (more than 1), with no restrictions on the number of USERS, or wishes to utilise the font software as a group of companies (operated under a holding company) a specific enterprise license must be

License To Use

This EULA is covers private testing and trialing usages ONLY.

PERMITTED USAGES / INSTALLATIONS

Trialing and Testing

By downloading any trial fonts that ALT.tf offer, THE LICENSEE agrees to use the trial font software for testing purposes only, and shall not publish work utilising the font software under this agreement publicly and / or online personally and / or commercially.

This EULA gives THE LICENSEE the right to share work / content / material with clients privately in perpetuity.

RESTRICTIONS

Modifications

THE LICENSEE may NOT, under any circumstances, adapt, modify, create additional versions/ weight/styles, modify existing characters, add characters, convert, rename font software under this agreement. Modifications are possible, but THE LICENSEE must contact ALT.tf for more information and how to acquire a customised license for the agreed upon modifications.

THE LICENSEE may NOT open font software under this agreement and / or purchased / and or distributed by ALT.tf in an editing software in order to reveal its structure, organisation or code.

All License Usages

THE LICENSEE may NOT under any circumstances publish or share publicly content / material / work utilising trials fonts downloaded from ALT.tf. They are for testing purposes ONLY.

Security

All the USERS must ensure that the installed font software under this agreement and / or purchased / and or distributed by ALT.tf is protected against any means of unauthorised access or against unauthorised use. The font software under this agreement MAY NOT be installed or used on a server that can be accessed by Internet, by another external network system (other than LAN) or by workstations which are not part of a licensed unit.

Non-Transferability

All trial licenses are non-transferable. This means THE LICENSEE may NOT transfer licenses to any other parties or clients, once the work has been completed, or at any given stage during usage.

Re-Sell
